Montréal is home to an unparalleled critical mass of Al researchers and doctoral candidates – many of them leading global authorities – as well as pioneering companies. This industry is made up of the following three sub-sectors: biopharmaceuticals, medical technologies and natural health products. Nearly 669 companies employ around 32,280 people. They are also several large multinationals in the biopharmaceutical and medical equipment sectors.

- Québec is recognized the world over for its creativity and expertise and the success of its productions, especially in the video game, visual effects and animation industries.
- Québec's level of investment in research and development is the highest in Canada.
- Its 18 institutions of higher learning, many of which rank among the world's top universities, train a highly skilled workforce whilst attracting over 50,000 international students each year from every corner of the globe.
- Montréal boasts the largest number of new university graduates in Canada, with over 50,000 annually.
- The province's industrial clusters, excellence hubs and industrial research coalitions help make Québec even more competitive in its driving sectors whilst fostering collaboration between the academic community and industry.

Natural resources



- The abundance of natural resources and vast energy potential of Québec's north create numerous business opportunities.
- Québec has deposits of several rare materials used in batteries, including lithium, graphite and cobalt.
- Québec is one of the world's biggest producers of hydroelectricity, with essentially 100% of its electricity coming from renewable sources.
- Québec supplies a full range of traditional and engineered wood products for a multitude of construction applications.

- Businesses can enhance their global competitiveness in Québec by taking advantage of the affordable labour costs, some of the world's lowest electricity rates, attractive leasing costs and tax rates that are amongst the most competitive in North America.
- Québec is known for offering competitive operating costs;
 - >The cost of electricity is 36% lower than in the US and 49% below the G7 average.
 - > Leasing costs for office space are 47% below those in the US and 51% lower, on average, than in G7 countries
- Québec offers financial incentives and a highly favourable fiscal framework.
