



# GUIDE (cont.)

## Personal consumption (Section 2, item 7)

In this form, the term "Personal consumption" is used to describe any products from your farm that you have taken for your own personal use.

## Rolling equipment (truck, tractor, other) (Section 2, items 16, 17 and 18)

If you use your vehicle for business and for personal use, the following expenses: gas, oil, insurance, registration, driver's licence, upkeep and repairs, and the interest on loans, are eligible as expenses in proportion to the business use only. If your vehicle is used for business purposes only, all the above expenses are completely deductible.

## Period ended

The date reported at the beginning of Section 4 – *DEBTS AND LIABILITIES OF THE FARM* must be the same as the date for the end of the period covered reported at the beginning of Section 2 – *STATEMENT OF REVENUES AND EXPENDITURES*.

## Debts and liabilities of the farm (Section 4)

Identify all creditors (for example: mortgage, collateral for your farm debts).

## The following documents must be available for any eventual verification

- Financial statements of your farm operation (report, statement of revenues and expenditures)
- Last year's federal and provincial income tax returns
- Accounting books and ledgers used for your farm operations
- Legal documents creating the farm operation
- Up-to-date bank passbooks
- Contracts and statements for: mortgages, collateral and personal and business loans.
- Contracts, invoices and supporting documents that were used to establish your revenues and expenditures.
