

# Fees

## Services provided to represented persons

Effective April 1, 2025

---

Under the *Regulation respecting the application of the Public Curator Act*, the Curateur public may charge fees for services associated with the protection of persons represented by the Curateur public and the administration of their property.

Fees are based on the cost of services rendered and market rates. They are indexed to the cost of living on April 1 each year and subject to federal and provincial taxes.

It should be noted that according to Act to limit the indexation of several government tariffs, adopted in December 2022, the indexation rate is limited to 3% from January 1, 2023, to December 31, 2026, a rate with which the Curateur public du Québec complies.



# Effective April 1, 2025, the Curateur public's fees are as follows:

## Person under private tutorship

Description	Rates
Procedure to institute tutorship	\$2,466 on receipt of judgment appointing a private tutor

**Note :** Additional fees may be charged (e.g., evaluation, birth certificate, subpoena to witnesses, legal stamp, bailiff's fees, etc.).

### Oversight of private tutorships

No fees are charged for overseeing private tutorships as a way to encourage families and loved ones to assume responsibility for persons.

### Waiving of fees

Under the law, the Curateur public has discretion regarding the charging of fees. It has drafted a directive according to which fees will not be charged **if the three following conditions are met:**

1. The person's monthly income does not exceed the amount of the maximum old age pension benefit plus the guaranteed income supplement for a single person;
2. The person has cash holdings of not more than \$2,500;
3. The value of the person's net assets does not exceed \$130,000.
