A report from a veterinary surgeon, based on examinations carried out in the month preceding the filing of the application, attesting that the animals listed in section 4, which will be imported into Québec, are in good health and, where applicable, complies with the conditions set out in section 14 of the Regulation respecting animals in captivity.

The results (if they exist) of any diagnostic tests carried out on the animals listed in section 4 to detect a pathogen contemplated in Schedule III of the Regulation respecting animals in captivity.

Where applicable, any veterinary document that can be used to assess the risk that the animals listed in section 4 may be carriers of a pathogen contemplated in Schedule III of the Regulation respecting animals in captivity.

A description of the steps that will be taken in respect of animals that may be handled by the general public, to prevent the transmission of zoonotic diseases.

In cases where high-risk mammals or venomous reptiles are kept in captivity, proof of civil liability insurance in the amount of \$2,000,000.

A cheque made out to the Ministre des Finances du Québec, in the amount of the fees payable for analysis of a licence application.
