Foreign nationals are classified to identify those who may be invited to submit an application for permanent selection. This ranking is established according to the score that these individuals will have obtained according to the following groups of criteria:

Human capital

A maximum score of 580 points is awarded for this group of criteria. It is broken down as follows:

a. Knowledge of French

The level is according to the <u>Échelle québécoise des niveaux de</u> <u>compétence en français des personnes immigrantes adultes</u> or its equivalent.

The workforce diagnosis for the profession is understood according to the list of medium-term diagnoses for the 500 professions in the National Occupational Classification in force. The profession is distinguished from the full-time job on the date of extraction from the expression of interest bank for the purposes of the invitation. The experience in the profession practised must have been acquired during the five years preceding the date of extraction from the expression of interest bank for the purposes of the invitation.

If the foreign national has more than one training, the most advantageous is retained. To award the point, account is taken of the recognition, by a professional order or other regulatory body, of the equivalence of a diploma or training obtained abroad.

The number of invitations issued in the same exercise can be established based on this ranking, starting with the highest ranked individuals.
