

## EXPLANATORY NOTES

### APPLICATION TO LIFT THE CONDITION OF DRIVING A ROAD VEHICLE EQUIPPED WITH AN ALCOHOL IGNITION INTERLOCK DEVICE FOR LIFE (SJ-1307A)

Fill out this form if your driver's licence is conditional on you driving a road vehicle equipped with an alcohol ignition interlock device for life and you wish to have this condition lifted by a judge of the Court of Québec.

#### TYPES OF FORMS

- Dynamic PDF:

After filling it out, you can print it on letter size paper, 21.59 × 27.94 cm (8.5 × 11 inches).

- Paper:

If you complete the form by hand, please write legibly in block letters.

#### PROCEDURE

Once the form is completed, keep a copy for your files.

#### FILING AT THE COURT OFFICE

Bring your completed application to the courthouse in your locality. Attach copies of any documents you intend to produce as evidence. The court clerk will assign you a file number and tell you the place, date and time the application will be presented before the judge, so that you can complete the "Notice of Presentation" section of the form.

#### FILING THROUGH THE DIGITAL COURT OFFICE OF QUÉBEC

To file your application through the Digital Court Office of Québec, you must first contact the office of your local courthouse to find out the place, date and time your application will be presented before the judge. Enter this information in the "Notice of presentation" section of the form.

Then go to <https://lexius-gnjq.justice.gouv.qc.ca/en/Accueil>, scroll down to "Grefe numérique judiciaire du Québec" and click on "File a document". Attach any documents you intend to produce as evidence. The court clerk will assign you a file number.

**General information**

**▶ Who can make this application?**

Fill out this form if your driver's licence is conditional on you driving a road vehicle equipped with an alcohol ignition interlock device for life and you wish to have this condition lifted by a judge of the Court of Québec. You can file this application if the Société de l'assurance automobile du Québec (SAAQ) has issued this conditional driver's licence following a second licence cancellation or suspension, and it has been more than 10 years since this condition was imposed.

**▶ Completing the application**

You must complete the top part, the "facts" section and the conclusion. You must also complete the "Notice of Presentation" section and the reverse of the form.

**TOP SECTION**

---

- ▶ Enter the judicial district and locality of the courthouse where you are filing your application.
- ▶ Enter the file number assigned to you by the court clerk.
- ▶ Enter your last name, first name, address and postal code in the section reserved for the applicant.

**THE FACTS** (the numbers of the explanatory notes refer to the corresponding sections of the form)

---

1. Enter the date on which the SAAQ cancelled or suspended your licence for an alcohol- or drug-related offence, having a high blood alcohol level, or failing or refusing to comply with a peace officer's demand in connection with alcohol or drugs.
2. Enter the date of the previous time the SAAQ cancelled or suspended your licence in the 10 years preceding this cancellation or suspension for one of the offences listed in the first paragraph.
3. Make sure this is your second licence cancellation or suspension.
4. Enter your driver's licence number and the date on which the SAAQ issued a driver's licence conditional on driving a road vehicle equipped with an alcohol ignition interlock device for life.
5. Make sure it has been more than 10 years since this condition was imposed.
6. Write down the reasons why your relationship with alcohol or drugs does not compromise the safe operation of a road vehicle.

**CONCLUSION** ("FOR THESE REASONS, I ASK THAT THE COURT...")

---

- ▶ The purpose of the application, namely to lift the condition requiring you to drive a road vehicle equipped with an alcohol ignition interlock device for life, is indicated in the "facts" section.

**NOTICE OF PRESENTATION**

---

- ▶ This notice will inform the SAAQ of the place, date and time your application will be presented to the judge.

**SERVICE OF THE APPLICATION**

---

- ▶ The SAAQ must be notified at least 60 days before the presentation date. The clerk will serve the SAAQ with the application, copies of any supporting documents, and the notice of presentation.

**REVERSE** (*This section must be completed and attached to your application*)

---

- ▶ Enter the file number assigned to you by the court clerk.
- ▶ Enter the judicial district and locality of the courthouse where you are filing your application.
- ▶ Enter your last name, first name, address, postal code and telephone number in the spaces indicated.

**You may ask the court clerk or their staff for help completing the application.**
