INFORMATION ON THE PROFILE OF A PERSON WHO HAS CONTRIBUTED TO THE PROCREATION OF A CHILD

(SJ-1361-NE)

The purpose of this form is to collect the legally required information stipulated in the [Regulation respecting information on the profile of a person who has contributed to the procreation of a child in the context of a parental project \(OC 106-2024\)](#) in order to document it for the child.

Situations covered by this form

1. Situations where profile information must be **collected** by the person alone or the spouses in a parental project involving the contribution of another person, and then **transmitted** with the declaration of birth to the registrar of civil status:
 - A parental project involving the use, between June 6, 2023 and June 6, 2025, of reproductive material from outside Québec through assisted procreation activities in a centre for assisted procreation.
2. Situations where profile information must be **collected** by the person alone or the spouses in a parental project involving the contribution of a third person, and then **transmitted** with the [court application for filiation](#):
 - A parental project involving surrogacy where the child's filiation must be changed by the court so that it can be established with regard to the intended parents (judicial route).

Information on the surrogate mother and any other party to the surrogacy agreement who has provided reproductive material must be collected and submitted along with the court application for filiation.
