

EXPLANATORY NOTES

POST-JUDGMENT EXAMINATION (art. 688 C.C.P.) (SJ-137A)

The “Post-judgment examination” form enables a judgment creditor or a bailiff to conduct an examination of a debtor with respect to his or her income, obligations and debts, any sums owing to the debtor, any property the debtor owns or has owned since incurring the debt that is the basis for the judgment, and the property that is the subject of the judgment.

TYPES OF FORMS

After completing the form, you must print it on legal-sized paper, i.e. 8.5 inches by 14 inches (215.9 mm by 355.6 mm). Be sure to set your printer to this paper size.

- Paper:

If you complete the form by hand, please write legibly in block letters.

PROCEDURE

Once the form is completed, keep a copy for your files.

The form must be sworn to, either before a commissioner for oaths, the court clerk of the applicable court or a person authorized to administer the oath.
