# ANSWER

(SJ-554A)

The "Answer" form is to be used by a defendant who wishes to personally answer a judicial demand against him or her before the Superior Court or the Civil Division of the Court of Québec. The form may also be used before the Youth Division, in adoption and protection matters.

**NOTE:** For a case before the Civil Division of the Court of Québec in a Jurisdiction 22 matter (File no. XXX-22-XXXXXX-XXX) **opened after June 29, 2023**, use the "Answer - Simplified Procedure" form (SJ-1272A) available at <a href="https://www.justice.gouv.gc.ca/centre-de-documentation">www.justice.gouv.gc.ca/centre-de-documentation</a>.

#### **TYPES OF FORMS**

Dynamic PDF:

After filling it out, you can print it on letter size paper, i.e.  $21.59 \times 27.94$  cm (8.5 × 11 inches).

Paper:

If you complete the form by hand, please write legibly in block letters.

### **PROCEDURE**

Once the form is completed, keep a copy for your files.

The answer must be notified to the counsel of the Plaintiff or, if the Plaintiff is not represented, to the Plaintiff. Notification can be done by any appropriate method proving that the document was remitted to its recipient (for example, by registered mail or bailiff).

If your address changes subsequently, inform the clerk by completing the "Notice of change of address" form (SJ-843A) available at <a href="https://www.justice.gouv.qc.ca/centre-de-documentation">www.justice.gouv.qc.ca/centre-de-documentation</a>.

## FILING AT THE COURT OFFICE

You must then submit the answer, with proof of notification, to the office of the courthouse. To do this, you may use the Digital Court Office of Québec (GNJQ), which is accessible at <a href="Québec.ca/justice-et-etat-civil/systeme-judiciaire/processus-judiciaire/services-judiciaires-numeriques">Québec.ca/justice-et-etat-civil/systeme-judiciaire/processus-judiciaire/services-judiciaires-numeriques</a>.
